



## **Suryapet Khammam Road Private Limited – (SKRPL)**

Suryapet Khammam Road Private Limited (the Company) (U45201GJ2019PTC107602) is domiciled in India and incorporated on 12th April 2019 under the provisions of the Companies Act, 2013 in India having its registered office at Adani Corporate House, Shantigram, Near Vaishno Devi Circle, S.G. Highway, Khodiyar, Ahmedabad - 382421 as a subsidiary of Adani Road Transport Limited.

Its primary business is to carry out the development, maintenance and management of the Project "Four Laning of the Suryapet (Design Ch.0.420/Existing Km. 128. 500 of NH-65) to Khammam (Design Ch.59.046/Existing Km. 50.750 of old SH42) of NH-365BB (Old SH-42) (Design Length = 58.626 Km) in the state of Telangana under Bharatmala Pariyojana on Hybrid Annuity Mode".

SKRPL is subsidiary of Adani Transport Limited. SKRPL aims to implement/develop 4 laning of the Suryapet to Khammam of NH-365BB (Old SH-42) (Design Length- 58.626 Km) in the State of Telangana under Bharatmala Pariyojana on HAM on design, build, operate and transfer basis.

The NHAI has awarded LOA vide LOA no. NHAI/Tech/AP/NH-365BB/Sur-Khm/2017-18/131849 dated 8th March, 2019 for Four Laning of Existing Two Lane from Suryapet (Design Ch.0.420/Existing Km. 128.500 of NH-65) to Khammam (Design Ch.59.046/Existing Km. 50.750 of Old SH42) of NH-365 BB (Old SH-42) (Design Length 58.626 Km) in the state of Telangana under Bharatmala Pariyojana on Hybrid Annuity Mode.. The estimated project cost was Rs. 1,566.30 cr with 40% Capex Grant received from NHAI during construction period and 60% has been funded by borrower in the form of debt and equity/ promoter contribution for implementation of the project. However, actual project cost incurred is Rs. 1,494 Cr.

## SKRPL Project background

The Project Road is NH – 365BB (old SH-42), which starts at Design Ch: 0/420 (Existing Ch: 128/500) Suryapet (New NH-65) and ends at Design Ch: 59/046 (Existing Ch: 50/750) on NH – 365BB (old SH – 42) after Thallampadu village. The Designed length of the stretch is 58.626 km. The project stretch is passes through Suryapet and Khammam Districts and mainly passes through Chivvemla, Chandupatla, Mothey, Mamillagudem, Naikanigudem, Kusumanchi, and ends after Thallampadu Village. The existing project road is a predominantly 2 lane carriageway with average width of 7m and 4-Lane is at few built up locations. The existing pavement is predominantly flexible pavement throughout the stretch. The existing pavement for the entire project stretch is flexible pavement. The condition of the pavement varies from Good to Poor. Earthen Shoulder is existing throughout the stretch varies from 1.0 to 2.0m. Pavement condition of the earthen shoulders is fair to poor. Many horizontal curves and vertical curves exist along the alignment. Among these, some curves are observed to have insufficient sight distance. Heavy vehicular traffic movement is leading to traffic congestion and mishaps. Due to the narrow roads the congestion will hinder free flow of vehicular traffic. To overcome these problems, it is essential to have bypass at Suryapet, Mothey Village, combined Naikanigudem, Paler, Kusumanchi and Thallampadu villages.

Roads and Buildings Department PPP wing, Government of Telangana has appointed M/s. Feedback Infra Pvt. Ltd. For providing the required consultancy services for PPP Techno-Economic Feasibility Study and Transaction Advisory Services for the project along with other 6 Project.

The project road Suryapet –Mothey -Khammam is In-Principle declared as National Highway and Subsequently Ministry vide letter no.RW/NH-12037/27/2016-(P-7)dated 29-4-16 requested Engineer –in-chief (R&B), Telangana to hand over the Suryapet-Mothey-Khammam to NHAI and project is transferred to National Highway Authority of India through tripartite-supplementary agreement.

The development of the project in widening of the existing road to four lane with two lane service road/slip road will result in safe and efficient traffic operation and will serve a vital role in accommodating the future growth of traffic.
